This is my 12th season with the Club and I have never seen a better catch brought to the weigh-in by all boats. Well, let us start from the beginning. Frank Nicoletti keeps his boat in Destin and I volunteered to join him running it over to Apalachicola. We took off on Wednesday morning and ran the Inter-coastal the 116 miles over. What a great ride, nice calm water and interesting shore line. The next morning we pre-fished the tournament along with Tom Holt, his brother Jimmy, my brother-in-law Bill Woodcock (Woody). We ran out to the Empire Mica and it was covered up with fish. We picked up AJ's, Snapper, Grouper, B-liners, Triggers...etcetera. With Red Snapper being closed in Federal waters till June, we released many large Reds.....So went the pre-fish.

The captains' meeting went well, with speaker Charles

Wilson providing us with his insight and 40 years experience in the area. He said "It's gonna' be rough out there". Well yes NOAA was calling for 4 to 6 foot seas, so many members were considering Bay fishing. Charles pointed out they have a great in-shore fishery, with 200+ lb. Tarpon, Big Redfish and nice Trout.

Friday morning most everyone got an early start heading to the Government Cut. I was fishing with Pat Thai, Dawn Brady and Jack Howland. Now Pat's boat is only a 22 walk around so we stuck our nose out and figured we could go out there but made a course for the Franklin County Reef. It's a 17 mile run and took a little over an hour. When we arrived on site, 3 other Club boats were already bringing in fish. Bill Rhodes, Tony Wilkins and Jim Mason were all anchored up. Later, other members showed, including Ted Dubose and Frank Nicoletti.

We didn't anchor, just motor-drifted against the current. As it turned out, members lost 3 anchors that day on the reef.

This reef is inside the 9 miles so Red Snappers were good to keep. We were able to pick up several snapper as well as 2 nice Cobia. Most boats caught Grouper too. All in all it was a good day to fish-----

Saturday morning the wind laid down a bit and let most boats go out to deeper water. We headed out to the Exxon Template, 29 miles out of the cut. On the way we picked up a few dozen live baits. Once out there we ran into Jim Mason and his crew who announced they had been getting many cut-offs on the platform. We joined them and had the same problem, hook ups ran into the



platform and broke off. After a little of that I motored over to the "S" tower a short distance away. We anchored up current and dropped live baits on floaters. Well it wasn't 3 minutes before Pat had a good one on and worked it to the boat. Nice AJ, we did that several more times and had our limit. Shortly after that Jack had a hook-up that turned out to be a rather large Cobia, (39.7 lbs) Good Job, Jack.... We continued to catch fish till we ran out of live bait, then it was back to bottom fishing with cut bait. We managed to pick up some good table fish but not much more for the weigh-in.

With time running out, we headed home with stink in the box. The weigh-in was unbelievable, never have I seen so many fish brought to the scales. Norm Bowen along with Steve Guntner ran the scales and did a great job. Mike helped out with the tallies and we had some great numbers and a couple of Club records..... Bill Zuber on Mike's boat collected the \$200 Big Fish Reward with his Club Record 51.5 Lb. AJ, nice going Bill.

As I said in the beginning, best tournament catches ever, and we all got back safe and tired, very tired....

Interim Orange Beach Tournament June 26 - 28





Help Out the Dolphin Tagging Program



The Dolphinfish Research Program continues to need your help in 2008. The Cooperative Science Services, LLC, a private fisheries research consulting company was founded by Don Hammond to continue the dolphin research project originally pioneered by the South Carolina Department of Natural Resources, or SCDNR. When commercial fishermen began targeting dolphin, major concerns arose among fishermen along the entire Gulf and Atlantic coasts. Anglers voiced fears that without a management plan governing harvest, dolphin stocks could be overfished to the point of major decline.

The SCDNR initiated the original research studies that allowed anglers to participate in efforts to understand many important unknown facets of the dolphin's life history. For example, little is known about the movements and migrations of the fish along the US's Atlantic and Gulf coasts. Defining the geographic range of the fish found in US waters is also very important in developing an effective management plan. Managers must know if the stocks fished in US waters are shared with other countries. In order to facilitate this research, a tagging study was initiated in 2006.

Last year the ASWSC distributed free tagging kits to membership, and the first fish known fish to be tagged in the Gulf of Mexico was achieved by our own ASWSC Outlaw crew. The club encourages continued tag & release efforts during this season. 
