

Atlanta Salt Water Sportsman's Club Duel at Destin July 15 – July 18, 2009

Best Bets: July in Destin there is something for everyone. Blue water trolling should be good for dolphin, wahoo and marlin. Deep drop on the SW edge for grouper, snapper, amberjack and blackfin tuna. Or fish the near shore waters for king mackerel.

Captain's Meeting: 7pm CDT, Wednesday, July 15 at Pirates Bay, poolside.

Awards Banquette: The Fort Walton Beach Sailfish Club, 27 Meigs Drive, Shalimar, FL 32549. 7:30 PM, Saturday, July 18, 2009.

Directions from Pirates Bay: turn right on 98 out of Pirates Bay. Take the Rt. 85 fork to the left and then the left onto 85 north (Eglin Pkwy). Go 4.1 miles on 85 and turn right between the Racetrack and McDonalds. At the stop sign, turn right on second street, straight through the next stop sign and stay on that street. The Sailfish Club is on the right after the road turns left.

Condo/Marina Facilities: Pirates Bay Condo/Marina (the weigh-in will be here). 214 Miracle Strip Pkwy, Ft. Walton Beach, FL 32548. Reservations: 800-356-1861. Information: 850-241-3154. Studio units are \$100 per night plus tax. Boat slips and trailer storage are no charge with room rental. The condo association has assured us that there will be a fish cleaning station installed prior to our visit.

Boat Launching Ramp: the most convenient boat ramp is next door to Pirates Bay at Liza Jackson Park (1/4 mile west of Pirates Bay). Trailer parking is available, check with the Pirates Bay main office.

Tournament Format: Fishing Thursday, Friday and Saturday, score using ASWSC Points Matrix. You may count your best two days (you don't have to fish all three).

Weigh-In: the weigh-in will be at Pirates Bay Marina, time will be announced at the Captain's meeting.

Club Raft Up: The Pensacola NAS Air Show is on Saturday. We plan to run the boats over to Pensacola and raft up as a group. Details and logistics will be covered at the Captain's Meeting.
