Condo/Marina Facilities:

Pirates Bay Condo/Marina: 214 Miracle Strip Pkwy, Ft. Walton Beach, FL 32548. Reservations: 800-356-1861, Option 1 (mention you are with the ASWSC for Club rates). Studio units are \$538.75 for 4 nights, tax and fees included, 3 nights, \$443.63, tax and fees included. Boat slips are extra at \$25/night for a 30' slip (slips also available without a room). Be advised this property is under new management and has a new cancellation policy (you must pay for the entire stay in advance and no refunds are offered if you cancel for any reason; however, they agreed to a compromise and will allow our members to reschedule within 12 months instead of just losing the money altogether (they suggest that all guests purchase trip insurance, but most policies won't cover a cancellation due to rough seas or a sick boat).

Resort Quest Management: 20% Club discount for The Islander property at 790 Santa Rosa BLVD, beachfront. 3 night minimum required, partial Gulf view rates per night for studio units \$92.80, 1 BR/2 BA units \$125.60, 2 BR/2BA units are all full Gulf view at \$151.20, plus tax and cleaning fee (all units here are full kitchens with sleeper sofas). Gulf Dunes property at 376 Santa Rosa BLVD, 2 BR \$203 and 3 BR \$254 per night, all units are full Gulf views. Cleaning fees: studio \$60, 1 BR \$70, 2 and 3 BR \$110. 15% deposit required on all properties with entire balance due within 4 days prior to arrival. Cancellation is forfeiture of 15% deposit or no forfeiture to reschedule trip within 12 months.
