Captains' Meeting: 7PM CDT, Wednesday, June 18, poolside at Pirates Bay (214 Miracle Strip Pkwy, F. Walton Beach, FL). No food or drink will be provided at this meeting.

Awards Dinner: Saturday June 21, tentative time 8:00pm CDT. Location TBD. Participants will select and pay for their own meals.

Condo/Marina Facilities:

Pirates Bay Condo/Marina: 214 Miracle Strip Pkwy **SW**, Ft. Walton Beach, FL 32548. Point of Contact: Vicky Fitzgerald, Reservations: 850-499-1706, (mention you are with the ASWSC). Pirates Bay Condos are on the ICW approximately seven miles from Destin East Pass. Each unit has a queen bed and sleeper sofa.

Club Rate is \$125/night + \$15 processing + \$35 damage fee + 11% tax (cost includes slip). Total for 4 nights = \$610.

- Trailer parking is available on a limited basis; check with the Pirates Bay main office.
- Note: If the club cancels the tournament due to unfavorable sea conditions, Pirates Bay is allowing us to cancel reservations (only the \$15 processing fee would be forfeited); otherwise, cancellations are not permitted. You are not required to cancel your reservation if the tournament is called off, but if you wish to cancel, you must do so by noon on Tuesday June 17th.
- Boat slips are available for \$25/night without condo rental.

Boat Launching Ramp: the most convenient boat ramp is just down the street from Pirates Bay at Liza Jackson Park (1/4 mile west of Pirates Bay).

Best Bets: This year red snapper season will be open (in FL state waters only). Most other species will be open as well, except for gag grouper, amberjack, and grey triggerfish. Offshore reefs and wrecks will hold a variety of bottom fish and it is a good time of year for trolling as well. Fish the near-shore waters for king mackerel or try inshore for trout & redfish.

Tournament Format: Fishing Thursday, Friday and Saturday. Best 2 of 3 days weigh-in scores count towards tournament points total. ASWSC Points Matrix scoring for tournament and Angler of the Year.

Tentative Weigh-In Times: Thursday and Friday 5:00 - 5:30pm; Saturday 4:30 - 5:00pm
