There is a grocery store on the island and a couple on LA 1 on the way south to Grand Isle. There is also a Walmart Supercenter on LA 1 approx. 34 mi north of Grand Isle. Grand Isle is approx. 568 miles from ATL, depending upon your starting point; the roads are good all the way down to Grand Isle. If the weather's too bad for fishing it is about 2 hours to the French Quarter.

Grand Isle is known for world class Yellowfin Tuna fishing offshore and a phenomenal inshore fishery, especially Redfish, along with many other inshore and offshore species available in this area.
