Yearly or Daily Fishing Licenses Required:

Yearly option: Louisiana basic fishing license (\$60) **and** a saltwater license (\$30) = \$90 total

Daily option: Louisiana 1-Day saltwater license = \$17.50/day

ABOUT GRAND ISLE: There is a very good grocery store on the island a few miles from Bridgeside. There is also a Walmart Supercenter on LA 1 approx. 34 mi north of Grand Isle (but you have to watch closely for it or you will zip on by it). Grand Isle is approx. 568 miles from ATL, depending upon your starting point; the roads are good all the way down to Grand Isle. If the weather is too bad for fishing, it is about 2 hours to the French Quarter.

FISHING: Grand Isle is known for world class Tuna fishing offshore and a phenomenal inshore fishery, especially Redfish, along with many other inshore and offshore species available in this area. In 2017 there were Tuna, Dolphin, King and Spanish Mackerel, a 25-pound Redfish (which you can keep in LA), Cobia, Red and Mangrove Snapper, Bonito and way too many sharks. We even had a couple of Swordfish hits.
