## Orange Beach Scramble Tip Sheet / October 10-15, 2021

**Captains Meeting and Dinner-** Sunday, October 10, 2021 at Cotton Bayou pool at 5:00 PM. We will have a poolside cookout with dogs, and all the fixin's, weather permitting. If you will be arriving later in the week, let the tournament director know so he can get any additional tournament and social information to you via e-mail or other methods to get you up to speed on the event and happenings.

**Tournament Fishing-** Fishing begins October 10<sup>th</sup> after Captains Meeting. The tournament will be a best three-day score of a possible five days that are available for weigh-in and fishing. You may fish any combination of the available Monday through Friday tournament days for weigh-in.

**Weigh-in** will be at Cotton Bayou fish cleaning station and docks October 11th through October 15th and the times are tentatively set as: Monday through Thursday 5:30-6:00 pm and Friday at 5:00-5:30 pm. Times will be confirmed at the Captains Meeting.

**Awards Banquet and Dinner-** Friday October 15th, 7:00 pm at Cotton Bayou poolside. It is mandatory that the tournament director has a completed application and payment by the October 1st deadline if you are going to attend the awards dinner, in order to ensure we have enough food for everyone.

**Where to stay:** Most club members will stay at Cotton Bayou Condos. Look on VRBO for reservations. **Condo Bayou is requiring every boat to pay a \$100.00 dockage fee for the week and provide proof of insurance, so please keep your paperwork on the boat.** When you arrive, see Barry (Cotton Bayou manager) in unit 5A to pay dockage (via cash or check only) to receive permit sticker and ramp lock code. There are many other great rentals in Orange Beach and surrounding areas; check VRBO and Air BnB.

**Additional Dockage:** Slips are included if you are staying at Cotton Bayou and pay the flat rate dockage fee. If you are not staying there and need dockage, try **Sportsman's Marina (251-981-6247)**. It is on Terry Cove, almost straight in from the pass; by land, 27844 Canal Road.

**Boat Ramps:** There are two decent public boat ramps: The Orange Beach Boat Ramp on Terry Cove at the end of Marina Road and Cotton Bayou ramp off of Perdido Beach Blvd (about 200 yards from Cotton Bayou Condos).

**Trailer/Boat storage:** Trailer storage at Cotton Bayou is limited. Your trailer must fit in your underneath parking space(s) to keep it on site. J&M Tackle has trailer storage behind the store; short term or month to month. Another option is a lot operated by (and next door to) Jones Canvas / 251-981-9407 / 27011 Canal Rd, Orange Bch AL 36561.

**Fishing Info:** There are thousands of artificial reefs between the Florida line and Mobile Bay that hold fish as well as good natural hard bottom further offshore. King mackerel fishing should be excellent along the beaches, Mobile oil rigs, and near shore reefs. Further offshore the dolphin, wahoo, tuna and marlin should all be possible catches. Be sure to check current regulations before fishing.

**Directions:** Orange Beach is a relatively easy drive; expressway most of the way. Take I-85 to Montgomery, then merge onto I-65 toward Mobile. Take the AL-287, Gulf Shores Parkway exit #37 toward Gulf Shores. Merge onto Hwy 59 south in Bay Minette. Take the Foley Beach Express (toll road) to avoid the traffic between Foley and Gulf Shores. The Foley Beach Express dead ends into Canal Road in Orange Beach.
